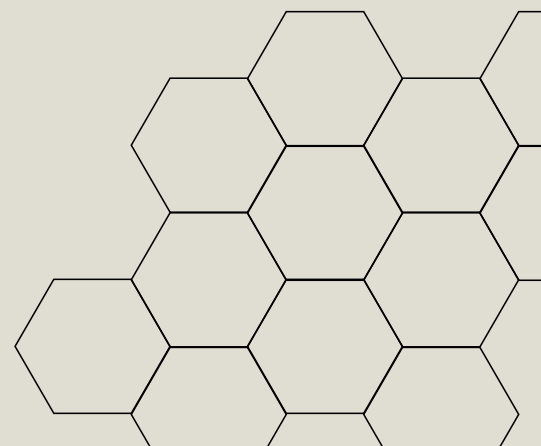

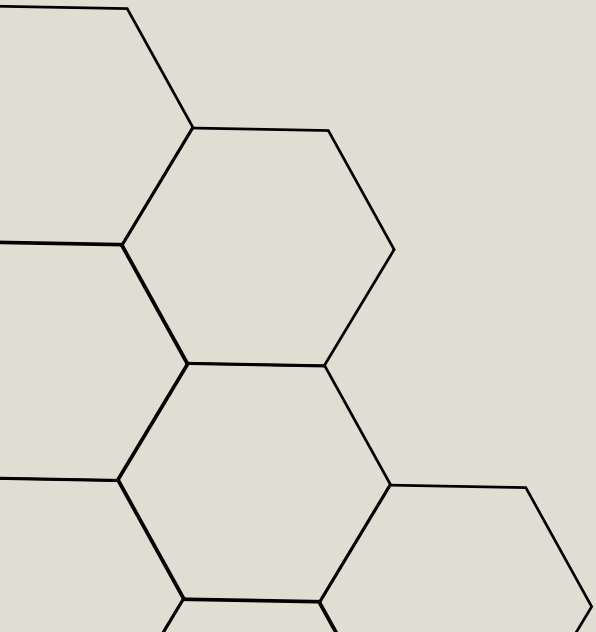
ABOUT RYTHM & BREWS
